<u>Application Forms:</u> Complete an application including all forms in this packet and return to the school office. No student with a delinquent account will be allowed to register.

The Medical Release form must be signed in order for your child to be registered. Parents will be notified of placement once enrollment has been accepted. Please fill out all forms completely and sign where indicated. All new and returning students must have a completed packet in order to register for the 2021-2022 school year.

Sports Program Fee: The sport program pre-registration fee is \$120 and late registration fee is \$145. This is a nonrefundable fee. Payment in full can be made by check made out to Crossroads Christian School, (CCS). Returned Check Fee: \$40.
